MEMORANDUM OF UNDERSTANDING

BETWEEN.

Indapur Taluka Shikshan Prasarak Mandal's College of Arts Bhigwan, Tal. Indapur, Dist. Pune and Subhash Baburao Kul College, Kedgaon Tal. Daund, Dist. Pune desiring to establish collaborative Relations between the two institutions to promote friendship and to cooperate in a mutually beneficial association have agreed that:





- 1. The two institutions shall encourage cooperation in any discipline that is studied in both institutions.
- 2. The two institutions shall seek to promote:
 - Exchange of information and materials that are of mutual interest
 - Exchange between the two institutions of:
 - Academic and administrative staff
 - Research staff& activities
 - Laboratory
 - Visiting scholars
 - Students
 - Other staff mutually agreed upon
 - Guest lecture
 - Library Cooperation and Resources sharing.(Inter Library Loan)
 - Various Activities
 - ♦ NAAC Co-operation
 - Provision of briefing by each institution to visitors from the other institution.
 - Other forms of cooperation, which the two institutions may jointly arrange and agree upon.

Details of any such activities will be subject to a separate Agreement.

- 3. The two institutions shall decide through consultation the specific areas and details of cooperation within the framework of this Agreement and shall consult each other mutually from time to time at the request of either institution for the purpose of reviewing the operation of this Agreement.
- 4. The financial arrangements involved in the implementation of this Agreements hall be settled through consultation between the two institutions in respect of each program area of cooperation.
- 5. The Agreement shall become operative on the last date indicated hereunder and shall remain in force for a period of five (5) years with an option to renew for another five (5) Years.
 - This Agreement may be amended and supplemented by agreement between the two institutions. Either institution may terminate this Agreement by giving six (6) months notice in writing to the other institution. Any projects, training, or exchange that may have commenced at either institution before the date of termination may be completed by special agreement between the two institutions. For conditions not covered by this Agreement, or for problems that arise during the course of this Agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.
- 7. The institutions shall confer concerning the renewal of this Memorandum of Understanding six (6) months prior to the date of expiration.
