This document constitutes an agreement between **Principal**, Indapur Taluka Shikshan Prasarak Manda's, College of Art's, bhigwan, Tal, Indapur, Dist. Pune, Maharashtra. Pin. 413130. And **President**, Rotary Club of bhigwan, Tal, Indapur, Dist. Pune, Maharashtra. Pin. 413130., with head office at Bhihwan.

• **1. Objectives of this MoU:-**

- 1) Through this MoU, Rotary Club of Bhigwan and Arts College Bhigwan will exchange activities and programs in terms of education, social environment, health, hygiene, women and child welfare etc.
- 2) Through this MoU, efforts should be made to exchange the educational activities of both the parties to reach the maximum number of beneficiaries.
- 3) Through this agreement, the social activities of both the parties will be carried out to the last level of the society.
- 4) Through this MoU, the innovative educational activities of the Rotary Club of Bhigwan will be used by the college students.
- 5) Through this MoU, the social activities implemented under Art College Bhigwan will be carried out to the society through Rotary Club Bhigwan.
- 6) Through this MoU, the aim is to inculcate interest in social service among the college students.
- 7) Through this memorandum of understanding, an effort will be made to make Art College Bhigwan as people-oriented as possible.

• **2. General Terms of this MoU:-**

2.1 Duration of MOU :- This MoU shall be operational upon signing and will have an initial duration of ten year's. All activities conducted



before this date within the vision of the joint collaboration will be deemed to fall under this MoU

2.2 Coordination : - In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities.

Principal College of Art's, bhigwan and **President**, Rotary Club of bhigwan, will meet regularly (preferably with two days' notice) to discuss progress and plan activities.

2.3 Educational and Social Assistance :- Annexures to this MoU will be developed for specific educational and social assistance activities. These annexes will detail each party's role responsibilities and educational social contributions.

2.4 Confidentiality :- Each party agrees that it shall not, at any time, after executing the activities of this MoU, disclose any information in relation to Educational, social, of these internal activities or the affairs of internal without consent of both parties.

2.5 Termination of MoU :- The partnership covered by this MoU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one month notice from either side. In the event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.

2.6 Extension of Agreement :- The MoU may be extended provided the parties agree upon, and can provide the necessary resources

2.7 Communications :- All notice, demands and other communication under this agreement in connection herewith shall be written in English language and shall be sent to the last known address, e-mail, or fax of the concerned party. Any notice shall be effective from the date on which it reaches the other party.



2.8 Addendum :- Any Addendum to this MoU shall be in writing and signed by both parties.

2.9 Insurance :- It is the responsibility of both parties to insure themselves against any loss of life. Both parties shall not be liable for sickness accident or any other kind of mutual liability.

• 3. Other Provisions of this MoU:-

3.1 Environmental Supplements :- According to this MoU, tree plantation and tree conservation activities will be carried out to maintain the balance of the environment through the coordination of both the bird.

3.2 Cleanliness Campaign :- According to this MoU, activities like village cleanliness campaign will be implemented through the coordination of both the parties.

3.3 Good Health:- According to this MoU, various health related activities will be implemented with the aim of raising the level of social health through the coordination of both the parties.

3.4 blood Donation:- According to this MoU, activities like Blood Donation Camp will be implemented through the coordination of both the parties.

3.5 Elimination of Superstitions :- Through this MoU, various social awareness activities will be implemented to eliminate superstitions in the society through the coordination of both the parties.

3.6 Community Enlightenment:- According to this MoU, various activities will be implemented in coordination between the two parties to eradicate the undesirable customs, traditions and bad customs in the society.

3.7 Technical Education:- Through this MoU, various educational activities will be implemented to impart technical education to the students through the coordination of both the parties.



3.8 Financial Support :- Through this MoU, various activities will be implemented in connection with providing educational materials to economically weaker students of the society.

3.9 Pranayama and Meditation :- According to this MoU, yoga, pranayama and meditation programs will be organized for students and citizens through the coordination of both the parties.

3.10 Social Protection :- According to this MoU, various activities will be implemented for the social protection of the women and students in the society by conducting a campaign against the injustice and oppression of the women in the coordination of the two parties.

The provisions and information of this MoU will be made available on both parties website. The terms and provisions of this MoU also apply to any subsequent addendum to this Agreement.
