As both the colleges have many areas of common interest in academic, education and research, considerable advantage may be gained from their pursuit on a collaborative basis in the said fields.

Now therefore, Both the colleges have decided to enter into this Memorandum of Understanding (MoU), which defines the framework for the cooperation in a mutually beneficial association have agreed that:

- The two institutions shall encourage co-operation in any discipline that is studied in both institutions.
- 2. The two institutions shall seek to promote:
  - Exchange of information and materials that are of mutual interest
  - Access to Research Laboratories & expertise for students and faculties.
  - Accommodation to the Visiting scholars
  - Organizing guest lectures
  - Library Co-operation and Resources sharing. (Inter Library Loan)
  - NAAC Co-operation
  - Provision of briefing by each institution to visitors from the other institution.
  - Collaboration in organizing seminars, conferences, workshops etc.
  - Co-operation in career guidance and placement related activities

## Details of any such activities will be subject to a separate Agreement.

- 3. The two institutions shall decide through consultation the specific areas and details of co-operation within the framework of this Agreement and shall consult each other mutually from time to time at the request of either institution for the purpose of reviewing the operation of this Agreement.
- 4. The financial arrangements involved in the implementation of this Agreements shall be settled through consultation between the two institutions in respect of each program area of co-operation.
- 5. The Agreement shall become operative on the last date indicated hereunder and shall remain in force for a period of Three (3) years with an option to renew it for another three (3) Years.
- 6. This Agreement may be amended and supplemented by agreement between the two institutions. Either institution may terminate this Agreement by giving six (6) months notice in writing to the other institution. Any projects, training, or exchange that may have commenced at either institution before the date of termination may

be completed by special agreement between the two institutions. For conditions not covered by this Agreement, or for problems that arise during the course of this Agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.

- 7. The institutions shall confer concerning the renewal of this Memorandum of Understanding six (6) months prior to the date of expiry.
- 8. This agreement is carried on day 12/04/2020
